BASIC INFORMATION

All electrical work being done in the Village of Bratenahl shall conform to the Amended Version of the National Electrical Code of current publication and accepted engineering practices. Fee schedules are subject to additional charges for electrical appurtenances. Revised 6/93. A rough and final electrical inspection is required on all electrical work. The fees for an electrical inspection are \$35.00 each and shall be in addition to the base fee plus line item fees. Additional inspections due to faulty/shoddy workmanship, and/or violations shall be an additional fee of \$50.00 for each occurrence. The Building Commissioner reserves the right to issue a "STOP ORDER" at any time he feels the work does not conform to proper standards and/or is in violation of Local, State or Federal Laws. Repeated violations will result in license revocation.
