BASIC INFORMATION

All heating and air conditioning work being done in the Village of Bratenahl shall conform to the Amended Version of the Ohio Mechanical Code of current publication and accepted engineering practices. Fee schedules are subject to additional charges for heating and air conditioning appurtenances. Revised 6/93 A rough and final heating and air conditioning inspection is required on all heating and air conditioning work. The fees for a heating and air conditioning inspection are \$35.00 each and shall be in addition to the base fee plus line item fees. Additional inspections due to faulty/shoddy workmanship, and/or violations shall be an additional fee of \$50.00 for each occurrence. The Building Commissioner reserves the right to issue a "STOP ORDER" at any time he feels the work does not conform to proper standards and/or is in violation of Local, State or Federal Laws. Repeated violations will result in license revocation. Steam or vapor boilers carrying a pressure of more than fifteen psig, in commercial structures or residential dwellings with six or more units or Hot water boiler exceeding one hundred sixty psig, or temperature exceeding two hundred fifty degrees Fahrenheit, in commercial structures or residential dwellings with six or more units. Must apply for permit from the State of Ohio Boiler and unfired Vessel department per OHIO REVISED CODE 4104.04
