PLEASE SUBMIT THE FOLLOWING WITH YOUR APPLICATION:

1. Bond in the minimum amount of fifty thousand dollars (\$50,000) in a type and form satisfy to the Village Solicitor, guaranteeing, work shall be done to the full satisfaction of the Village, area affected by the work shall be restored as nearly as possible to its original condition, such condition maintained at the cost of the permit holder for a period of one year after completion. Bond to indemnify and hold harmless the Village, its officers and employees, from any damage caused by the applicant and to protect the Village from and related damage.
2. Site Plan indicating the exact location of the proposed opening, excavation, tunnel or curb cut. Included area and depth, list of replacement material (Per O.D.O.T. standards), safety measures, barricades, plates, fences, etc (**Barricades required at all times**), warning lights (Dusk to Dawn Required).

Drawings are to have a scale of 1/4"=1'

Note: Streets, sidewalks, other public areas shall be kept opened unless authorized by the Streets Commissioner.

Note: The opening and restoration of street or sidewalk shall be overseen by the Village Engineer contact the Building Department 72 hrs prior to starting project and or covering.

Upon failure or refusal of the permittee to satisfactorily fill the excavation, restore the surface and remove all excess materials within the time specified in the permit or, where not specified therein, within a reasonable time after the commencement of the work, the Village may proceed without notice to make such fill and restoration and the bond referred to in Section 901.05 shall be deemed forfeited. If the amount of such services performed by the Village shall exceed the amount of the bond, the Village Solicitor and Clerk shall proceed to collect the remainder due from the permittee.

901.99 PENALTY – Whoever violates any provision of this chapter is guilty of a minor misdemeanor.

Any such violation shall constitute a separate offense for each day.

PLEASE NOTE: Any special requirements or conditions can be imposed upon this permit prior to signing off by the Village Engineer upon final inspection.
